







Terms of Reference (TOR)

For the development of regional project proposals to promote decarbonization and climate resilience in Central Africa.

UNIDO Project Title: "First operational phase of the Centre for Renewable Energy and Energy Efficiency for Central Africa (ID 200138)"

24 May 2023

1. GENERAL BACKGROUND INFORMATION

Central Africa is a region with abundant and varied renewable energy sources including solar, wind, hydropower, geothermal, biomass, and other conventional energy sources. Paradoxically, it is also the region with the lowest average access rate to energy in Africa, negatively affecting regional socio-economic development.

To address these issues, the revised treaty establishing the Economic Community of Central African States (ECCAS), particularly its protocol encouraging cooperation between Member States within the energy field, is leveraged. Further, ECCAS with the assistance of the United Nations Industrial Development Organization (UNIDO), conducted feasibility studies relating to establishing and operationalizing the Centre for Renewable Energy and Energy Efficiency for Central Africa (CEREEAC).

The Energy Ministers adopted the establishment of CEREEAC on June 8, 2021. Decision No. 04/CEEAC/CCEG/XIX/21 of the 19th Conference of Heads of State and Government held in Brazzaville on 30 July 2021, formally established the Centre. Following a selection process, Angola was designated as the host country for the CEREEAC Secretariat.

On December 08, 2021, ECCAS, in partnership with UNIDO and IRENA, organized a virtual round table of donors, with a view to mobilizing funds needed for the start-up and operation of CEREEAC. Multiple partners have expressed interest in supporting the center and the deployment of renewables in Central Africa. Notably, the International Organization of Francophonie (abbreviated as OIF in French), through its subsidiary body, the Institute of Francophonie for Sustainable Development (abbreviated as IFDD in French), has committed to supporting the development of renewables in Central Africa and funding this assignment.

Currently, UNIDO is providing technical support to the operationalization of CEREEAC (hosted in Angola). CEREEAC was inaugurated on 10th March 2023 with consensus and full support from all ECCAS member states. The Centre will serve to promote renewables and energy efficiency and to create an integrated and inclusive ECCAS market for related products and services within the region. CEREEAC will also benefit from cross-cutting collaboration with other regional centres of the Global Network of Regional Sustainable Energy Centers (GN-SEC), which is coordinated by UNIDO.

2. PROJECT CONTEXT

To strengthen the technical portfolio of the CEREEAC and to foster project-based partnerships within the region, UNIDO is seeking flexible consulting support for the development of regional project









concepts and documents, to be submitted to multilateral donors for approval, with a primary focus on the Green Climate Fund (GCF), the European Union (EU) and the Adaptation Fund (AF).¹

The proposals are expected to incorporate adaptation and mitigation approaches, and energy-waterclimate change nexus. Gender, food systems, climate resiliency, and adaptive measures are important crosscutting thematic areas of these proposals. This work will require extensive consultations with local regional/national stakeholders, particularly in the Congo Basin and Central African countries.

Relevant thematic project themes may include: institutional capacity building, distributed renewable energy systems and rural mini-grids, investment promotion for renewable energy, storage and smart grid infrastructure, organic waste to energy and nature-based energy solutions, industrial energy efficiency, climate resiliency and adaption measures, energy data, energy planning and infrastructure, and power systems, as well as clean tech entrepreneurship, innovation and cluster building. Besides these, the potential bidders are welcome to suggest complementary themes that have the due relevance and impact for the beneficiaries and for the donors' approval.

3. THE SCOPE OF THE PROPOSED CONTRACTED SERVICES, DELIVERABLES

The contracted services will be requested by UNIDO over a nine (9) months period. Before commencing specific assignment tasks, the UNIDO project team and the contractor will agree on the required scope of the work package. The detailed work scope is described in the table below.

All documents will be provided by the contractor fully edited, designed (incl. graphs) and ready to be published in English. In addition, the contractor will be required to deliver the following:

- Item High-resolution photographs (min. 3 MB, at least 20) that illustrate the undertaken activities (e.g. showcasing relevant meetings with stakeholders, energy infrastructure or project sites). The consultants will cede all appertaining rights to unlimited use of the respective pictures to UNIDO and CEREEAC.
- Item All used raw files and calculation sheets in editable form (e.g. xls). All files need to be handed over and become property of UNIDO and CEREEAC. Collected data will be distributed through the regional energy information system.

5. COORDINATION AND REPORTING

The contractor will report to the UNIDO Project Manager and his team in the UNIDO Headquarters (Vienna) and will closely coordinate with the centre (CEREEAC) representatives and local stakeholders, as required. The PM and the project team will support the project development efforts of the contractor.

6. PERSONNEL IN THE FIELD

While the presence of personnel in the Central Africa is not mandatory for this assignment, having a member of the team stationed within the region will be considered an advantage. Accordingly, the bidders have to clearly state in their financial and technical proposals the specific tasks and related working days, both for the personnel in the field and home based.

7. LANGUAGE REQUIREMENTS

The working languages for this assignment will be French and English. Portuguese proficiency of at least one team member will be required for project development involving the lusophone countries in the region.

8. AVAILABLE BUDGET

The available all-inclusive budget for this assignment is Euro 80,000.00 (eighty thousand Euros).

- **Technical Proposal** (including proposed approach and methodology, work and activity plan, detailed CVs of experts, copies of university degrees, certifications, licenses as well as a proven track record of implemented assignments);
- **Financial Proposal** in EUR including all costs and taxes; offers without clearly stating the allin price will be rejected;
- Documents demonstrating the quality of the track record of the project team with regard to relevant previous assignments and project documents.
